Affiliate Membership Application

Affiliate Membership Eligibility – Affiliate Members shall be firms legally engaged in practices which are directly or indirectly associated with or supportive of the organized construction industry. The purpose of the West Michigan Construction Alliance (WMCA) Affiliate Membership program is to provide a structure for Affiliate Members’ participation in WMCA matters while promoting the common business interests of construction labor/management within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1986 as amended. Examples of affiliate membership include but are limited to architectural firms, construction managers, suppliers, manufacturers, insurers, legal and financial institutions. Membership shall be confirmed by a majority vote of the Board. Affiliate Members shall not have any voting rights.
